# Q&A - BC PR Planning and Action Program

- Submitted by local governments in BC with Council or Board resolution (support for activities and willingness to manage the grant)
- 2 streams:
  - Stream 1 to develop/update a poverty reduction strategy (up to \$25,000)
  - Stream 2 to implement a local PR project/strategy (up to \$50,000).
- Applications must:
  - Align with one or more of the six priority action areas of *Together BC*
  - Directly involve people with LE, businesses, and local Indigenous orgs
  - Present anticipated outcomes (e.g. performance measures/benchmarks)
  - Have a plan to sustain the project beyond the 1-year funding cycle

# Types of Tamarack Learning Supports

- **Coaching** (1-on-1 Manager of Cities; Expert Coaching)
- **Peer Learning** (Communities of Practice [CoPs], Peer-Input-Process [PiP] Troubleshooting Sessions), Mentoring)
- **Face-to-Face Events** (Summits, Gatherings, Workshops)
- **Online Learning** (Webinars, Website, Newsletter, Social)
- **Publications** (Case Studies, Tools, Guides, Articles, Blogs)

# Ideas for Tamarack Learning Supports

<b>Engaging Local Governments</b>	Identifying municipal champions; Making the case/ask; Gaining buy-in and commitment; Building and sustaining momentum
<b>Multisectoral Collaboration</b>	Collaborative leadership; Collective Impact; Engaging people with lived/living experience, business and local Indigenous organizations; Recommended practices for funding inclusion
<b>Evaluation</b>	Sourcing local data; Understanding and telling the local story of poverty; performance measures/benchmarks; tracking and reporting on outcomes and impact
<b>Sustainability</b>	Sustainability self-assessment (leadership and \$); Financial health

## **Stream 1 – Developing a Community Plan**

*Expert and MoC coaching, 3-part CoP series, peer support, tools and guides.*

## **Engaging 4 sectors (including lived/living experience) in developing a community-wide common agenda and community plan:**

- Community Engagement: Building a Momentum for Change
- Developing a Strategy and Writing the Plan

## **Stream 2 – Implementing the Plan**

*Case studies, stories of success stories, troubleshooting strategies and connections from across the network.*

## **Addressing *TogetherBC's* Priority Action Areas:**

- Housing; Families; Children/Youth; Education/Training; Employment; Income; Social supports. Mental Health/Addictions
- Reduced-fare transit and recreation passes
- Financial security through tax-filing programs
- Awareness campaigns to reduce stigma and promote inclusion
- Social Enterprises that provide supportive employment
- Local food security initiatives (access; food-waste; kitchens)
