## The COMMUNITY is the EVALUATOR The EVALUATOR is the COMMUNITY





### WHO PARTICIPATES?


Anyone who will have impact on, or be affected by, the project, issue or initiative.

**Context Experts** are residents with lived experience, including children and youth. They are the people who experientially know about the issue.

**Content Experts** are professionals, staff in your organization, service providers, and leaders with formal power who have knowledge, tools, and resources to address the issue.



### **MAPPING YOUR EVALUATION ECOSYSTEM**





• Empowers informants/participants

Encourages meaningful engagement practices Builds capacity of citizens and local actors

Strengthens connections among citizens and build and strengthen relationships overall

- Questions and data stay locally & culturally relevant leading to higher value among community members
- Greater accuracy & relevance of findings
- Encourages locally ownership of outcomes and findings
- Improves program performance community actions
- Sustain organizational/community learning and growth
- Greater opportunity to scale learning and practices

## HOW TO ENGAGE IN PARTICIPATORY EVALUATION?

- Early reflections on objectives and project planning
- Evaluation governance (evaluation committee...)
- Evaluation questions: what do we want to measure AND Learn
- Indicators design
- Data collection
- Collective analysis
- Sharing and using results and learnings





Placing community at the centre of evaluation


